TERMS AND CONDITIONS

Applicant and each individual, shareholder, partner, and member signing as "Applicant" (each such individual, shareholder, partner or member, an "Owner") certify that the information provided in this application ("Application") is accurate and complete as of the date hereof and Applicant and each Owner agree to promptly notify Crown Trucking LLC (together with its affiliates and subsidiaries, collectively, "Crown Trucking LLC") of any change to the information provided or such Applicant or Owner's financial status. Each individual signing this Application on behalf of Applicant, or an Owner expressly authorizes Crown Trucking LLC and/or its affiliates, agents, designees, assigns or lending sources to investigate Applicant's credit, and to make any credit inquiries that Crown Trucking LLC deems necessary including an inquiry into Applicant's current and past banks, lending institutions or any other creditors. Applicant authorizes banking institutions, lending institutions, trade references, and other creditors to release and disclose to Crown Trucking LLC, Applicant's credit history and credit information normally released to a prospective creditor. Applicant releases and waives all claims against Crown Trucking LLC for any act or omission that may occur in verifying the information herein. Applicant understands that Crown Trucking LLC's payment terms are Net 30 unless otherwise agreed to in writing, and agrees to pay all invoices according to these terms. Applicant further understands that all past due accounts are subject to a 1.5% Finance Charge on all invoices 30 days or more past due, which is an annual percentage rate of 18%, and agrees to pay such charges according to these terms along with all costs of collection, including reasonable attorney's fees incurred by Crown Trucking LLC in collecting any past due balance. Applicant expressly consents to Crown Trucking LLC protecting its lien rights including, but not limited to, filing preliminary notices for work done in states where such notices are

required. Applicant further agrees to be bound by Crown Trucking LLC's standard form rental contract in use at the time of each rental transaction, the terms and conditions of which are incorporated into this Credit Application in their entirety, regardless of whether Applicant executes such rental contract. Upon Applicant's or Owner's request, Crown Trucking LLC, and/or its affiliates, agents, designees, assignees, or lending sources, to the extent any of the foregoing requests a credit report in connection with this Application, may advise Applicant or Owner (as applicable) whether a credit report was requested and, if so, the name and address of the credit reporting agency that furnished the report. By signing this Application, Applicant and each Owner signing as "Applicant" direct Crown Trucking LLC and/or its affiliates, agents, designees and assigns to disclose or otherwise transmit any and all information and documents that Crown Trucking LLC may obtain, including, without limitation, business or personal credit reports, this Application, and any "personal information" (as defined under the California Consumer Privacy Act or other similar applicable laws, however, personal information or data may be defined thereunder), to other persons that are involved in providing commercial funding and the services related thereto (including, but not limited to, Crown Trucking LLC's lending sources and its and their third-party service providers), in each case for the purposes of facilitating the provision of commercial funding for Applicant or the ongoing facilitation or administration of any funded transaction. All such personal information shall be collected, stored, disclosed, and used by Crown Trucking LLC's and/or its affiliates in accordance with applicable laws and Crown Trucking LLC's privacy policy (which can be found at crowntrucking.net). Applicant and Crown Trucking LLC agree that any action, suit, or proceeding related to or arising out of this Application shall exclusively be brought in the federal or state courts located in the State of Arizona, and both Applicant and Crown Trucking LLC expressly submit to the jurisdiction of such courts with respect to any such action, suit or proceeding. This application may be signed in counterparts of which each copy shall constitute together a complete document. If any provision of this Application is found to be unenforceable, such provision will be fully severable from this Application and the remaining provisions of this Application will remain in full force and effect.

GUARANTY

In consideration of the extension of credit to ("Customer"), the undersigned guarantor(s) ("Undersigned") jointly, unconditionally, and irrevocably guarantees to Crown Trucking LLC (together with its affiliates and subsidiaries, collectively "Crown Trucking LLC") the full and prompt payment, performance and satisfaction by Customer of each and every one of its obligations to Crown Trucking LLC, whether now in existence or arising on or after the date of this Guaranty whether absolute or contingent, and whether secured or unsecured, together with all fees and charges of whatsoever kind and nature arising therefrom or relating thereto. The Undersigned further agrees to indemnify Crown Trucking LLC and hold it harmless from any loss, cost or expense (including, without limitation, reasonable attorney's fees and other costs of collection) arising from or as a result of any breach by Customer of its obligations to Crown Trucking LLC or any breach by the Undersigned of Undersigned's obligations under this Guaranty.

The Undersigned hereby waives demand for payment under this Guaranty, protest, presentment, any applicable homestead exemption(s), a notice of acceptance of this Guaranty, all set-offs and counterclaims; and all other notices customarily given and/or to which the Undersigned would otherwise be entitled. It is expressly understood that Crown Trucking LLC will not be required to exhaust its legal remedies for recovery against Customer before seeking payment from the Undersigned and that the Undersigned is obligated, absolutely and immediately, to pay any amount owed to Crown Trucking LLC by Customer and/or to perform any obligation due to Crown Trucking LLC by Customer immediately upon Customer's failure to timely pay or perform. This is intended to be, and is, a continuing Guaranty applying to all transactions effected or to be effected, between Crown Trucking LLC and Customer and shall not be revoked by the Undersigned except upon the receipt of written notice via certified mail with proof of delivery by Crown Trucking LLC from the Undersigned, addressed to the attention of Crown Trucking LLC's general counsel, to not enter into further agreements with Customer on the security of this Guaranty. Such revocation will only be effective with respect to any obligations by the Customer arising after the date such written revocation was received by Crown Trucking LLC.

This Guaranty is governed by the laws of the State of Missouri, without regard to conflict of laws principles. The undersigned and Crown Trucking LLC agree that any judicial proceeding to resolve claims relating to this Guaranty will be brought to the federal or state courts of Peoria, AZ, Pheonix AZ, or both. Both the Undersigned and Crown Trucking LLC consent to venue and personal jurisdiction in such courts. The Undersigned further agrees and authorizes Crown Trucking LLC to investigate Undersigned's credit and financial information through any credit bureau or any other reasonable means including direct contact with past and present creditors.
